



Regulations of the Scout Station "Bukowina" in Binowo Szczecin Scout District of the Polish Scout Association

Applicable from 1.05.2023

(translation: google translator, sorry for context mistakes)

1. The Scout Station "Bukowina", hereinafter referred to as the station, is managed by the Szczecin Scout District. Decisions related to the management of the base are made by the Commander of the Szczecin Scout District or a member of the Szczecin Scout District Command appointed by him for this purpose.

2. The station has a Commander who is responsible for its proper functioning, taking care of its technical condition and coordinating its use by organized groups of participants. The Commander of the Station is appointed by the Commander of the Szczecin Scout District, to whom he is directly subordinate. The campsite is adapted to organize the following forms of activity:

a. Forms of scouting work (including camping, camping, facilities for rallies, jamborees and meetings and courses);

b. Facilities for entities not related to the Polish Scouting Association, but thematically related to tourism, sports, sightseeing, education, ecology, historical reconstruction, etc.

3. The campsite is adapted to overnight stays at the campsite and in camping cabins in the period from May 1 to October 31. Outside this period, the sanitary facilities and kitchen facilities are closed. The cabins are not adapted to overnight stays and heating in the autumn-winter period.

4. Use of the base in the period from October 31 to May 1 is only permitted in the form of one-day meetings such as: meetings, rallies, jamborees and farm work. Overnight stays are excluded in this period.

5. The campsite is not adapted for the stay of individuals for recreational and camping purposes or for the purpose of organizing feast-type events. It does not have the possibility of servicing campers and coaches, it does not have a reception or service for individuals. 6. The campsite has facilities for preparing meals and sanitary facilities with toilets, sinks and showers, which are permitted for independent use by participants. The maintenance of cleanliness in these rooms is the responsibility of the users. The Szczecin Scout Association provides service in the form of cleaning agents and preparation of rooms for use.

7. Due to its sanitary capabilities, the campsite can accommodate a maximum of 100 people at one time. A larger number of participants is associated with the need to provide additional toilet stations and mobile sanitary facilities. 8. Number of overnight places at the campsite - about 130, including:

a. 10 cottages (including bunk beds) - a total of 70 places,

b. 2 green detached cottages: 8 places,

c. Campsite - space for about 12 3-4 person tents - about 50 places.

9. The stay of participants at the campsite is approved by the Camp Commandant via the application form located on the website of the Szczecin Scout District www.szczecin.zhp.pl in the "Bukowina Campsite" tab. The stay is accepted when the applicant receives confirmation of the reservation.

10. The cost of staying at the campsite is specified in the Resolution of the Szczecin Scout District Command and is published on the Camp's website. The fee includes: the cost of accommodation at the campsite (in your own tent) or in a cottage, use of the campsite infrastructure, use of the kitchen container, use of sanitary facilities: hot and cold water, toilet; cleaning products: toilet paper, liquid soap, dishwashing liquid.

11. Additional fees included in the price list: a. fee for excessive electricity consumption calculated based on the readings of the electricity meter, b. waste disposal fee (in the event of the need to provide a container for waste removal).

12. The campsite is adapted to accommodate several scout units at the same time. Exclusive reservations for the campsite are possible in exceptional cases, after consultation with the Commandant of the Szczecin ZHP Scout District. The stay of scout groups from the Szczecin ZHP Scout District at the campsite is possible in an independent form, without the service of the base by the district.

13. The stay of non-scout or foreign groups at the station requires coordination or supervision by the commander of the station.

14. The stay of large groups (over 80 people) or non-scout groups, in addition to reporting via the form, requires an advance payment of 20% of the estimated cost of the group's stay to the account of the Szczecin ZHP Troop. The current account number can be found on the Szczecin ZHP Troop website at szczecin.zhp.pl. The advance payment can be returned only in the event of cancellation of the stay no later than 14 days before the start of the stay.

15. The stay of large groups (over 80 people) or non-scout groups requires the preparation of an agreement, which will include the obligations of the organizer of the stay and a list of persons responsible for the stay of participants. The party to conclude the Agreement is the Commandant of the Szczecin ZHP Troop.

16. Participants are obliged to comply with fire safety regulations. Campfires may be lit only in designated areas (3 marked areas). It is forbidden to leave fires unattended. Smoking and the use of open fire, as well as the use of fireworks, firecrackers and other items that may cause a forest fire are prohibited throughout the camp.

17. The end of the participants' stay requires the organizer to check the condition of the camp (in terms of order and technical condition), record the reading of electricity meters and pass it on to the troop representative. The participants are responsible for restoring the accommodation, kitchen and sanitary facilities to order - the list of cleaning activities has been specified in the stay regulations.

18. The entry of motor vehicles into the base is limited and should be supervised by the stay organizer. Vehicles should park in the parking lot in front of the barrier, while the entry of vehicles into the base should be temporary, with particular caution being exercised due to the participants' stay. The barrier should be constantly lowered to prevent unauthorized persons from entering the base.

19. The main gate should be closed at night (not necessarily with a padlock), due to the possibility of entry into the base of wild animals. The fenced base is a trap for them and may pose a threat to participants.

20. It is forbidden to consume alcohol, use nicotine, drugs, stimulants and other substances considered intoxicating on the campsite.

21. Dogs are allowed on the campsite provided that the owner ensures uninterrupted care and control of the animal. The animal should have current vaccinations, especially mandatory vaccination against rabies. The owner should have a leash and a muzzle ready for use. At night, it is mandatory to secure the animal so that it does not move around the campsite on its own. The owner is responsible for any damage caused by the animal. During the stay of several groups of children and youth, dogs may stay on the campsite only on a leash, only after obtaining the consent of all organizers of camps taking place at the same time. In the event that such consents are not obtained, the presence of a dog at the station is not permitted.

22. The stay of participants in scout groups should take place within the framework of the current provisions of Polish Law, in particular the guidelines of the Education Board and the internal regulations of the Polish Scouting Association. The stay of other groups is regulated by the provisions of Polish Law and the organisation of the event is the responsibility of the given organiser.

23. The Szczecin Scout Association Command reserves the right to refuse to book a stay or interrupt the stay of groups that violate Scout Law, the provisions of these regulations or do not meet the criteria necessary to implement these regulations.

24. The final interpretation of the provisions of these regulations belongs to the Commandant of the Szczecin Scout Association Szczecin Scout Association.
